Financial Highlights

The Historical Society experienced a revenue shortfall in the year ended June 30, 2016. There were several factors leading to decreased contributions, including major donors moving out of the area and, we believe, some impact from the campus expansion project. The investment portfolio, \$4.8 million at June 30, incurred unrealized losses of about 7% for the year, reflecting a volatile market. The increase in other current assets represents capital campaign funds for the restoration and expansion of the campus. The operating budget for FY17 is balanced—and conservative—and we expect to live within it. The audited financial statements and IRS Form 990 will be posted on our website. And, finally, thank you for your continued support.

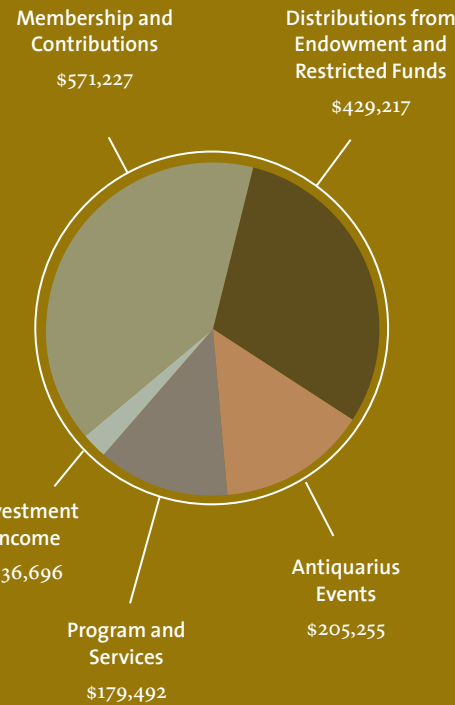

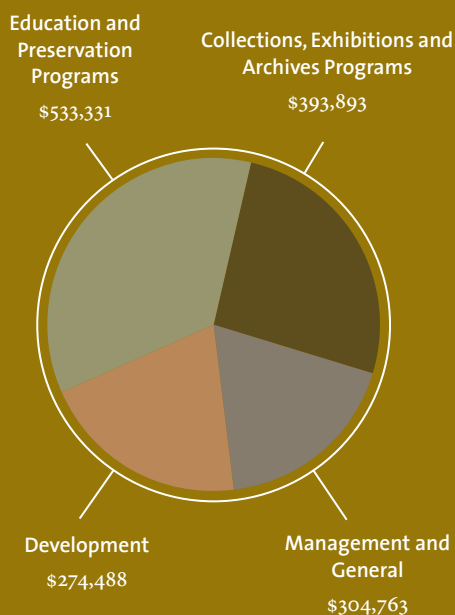
Operating Revenues

Letter from the Chairman and Executive Director



The Greenwich Historical Society plays a unique and vital role in Greenwich. It is the only organization dedicated solely to preserving and sharing the history of the Town of Greenwich, and every year since its founding in 1931, it has faithfully sought to fulfill that crucial role while meeting the changing needs of our community.

In 2015–16, the Historical Society welcomed almost 14,000 individuals to our Strickland Road site and over 33,000 virtual visitors to our expanded website. We offered interactive exhibitions; on-site, off-site and online archival research services and expanded education and school programs, and we continued to share and to preserve Bush-Holley Historic Site with visitors from near and far.

Preservation was high on our list. We presented five “Greenwich Landmark Recognition” plaques to homeowners of historic structures, bringing the total as of April 2016 to 298. We also installed the first Greenwich Historic District sign to identify the Greenwich Municipal Historic District, an initiative of the Historical Society’s nascent Greenwich Preservation Network.

We were pleased to share treasures from our collections in two engaging exhibitions: *Greenwich Choices: Fifty Objects That Illustrate Our History* and *Close to the Wind: Our Maritime History*. And, so that we may continue to offer and improve our exhibition and archival resources, we completed a conditions assessment for short- and long-term care of the entire site and its collections, generously funded by the CT Humanities Council.

Most importantly, the Historical Society made significant progress on its Master Plan to substantially increase services to the community through expanded facilities, educational programming, improved accessibility and improved collections care and storage. We are indeed proud to announce that we have secured:

- * A final lease with Connecticut DOT for exclusive use of the parking lot under I-95
- * Final approval from Planning and Zoning for the expanded site plan
- * Funds from the Community Development Block Grant Committee to provide an accessible elevator for the newly expanded site

We extend our deepest appreciation for the exceptional generosity and commitment of the Board of Trustees, devoted volunteers, faithful members and dedicated staff in ensuring our ongoing success. Read on to discover the role your support has helped us play in our beloved community!

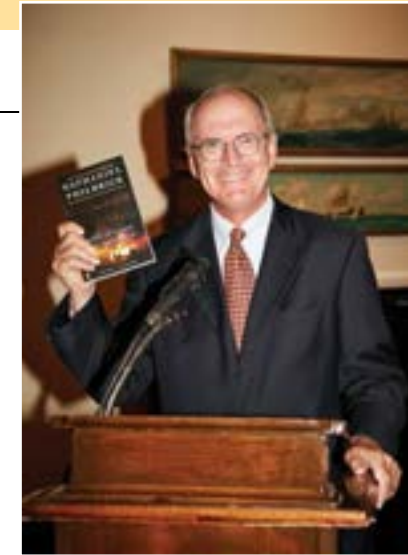

History Lives Here Preservation and Outreach

Community outreach is key to our mission. With continuing demolitions of noteworthy historic structures throughout Greenwich, the need to spread the word on how and why we should protect and preserve the town's architectural heritage has never been greater. In 2015-16, the Landmarks Recognition Program operated on multiple fronts to document the town's most significant historic structures, to recognize the efforts of individuals who restored historic buildings and to promote the beauty and benefit of architectural preservation and adaptive reuse.

Seeking to impress upon residents the wealth of history waiting to be discovered around every corner, the Greenwich Preservation Network, in partnership with the Town of Greenwich, celebrated the installation of a historic marker in the Downtown Historic District at the corner of Greenwich Avenue and Arch Street, the first in a series that will mark historic districts throughout town.

We celebrated the town's 375th anniversary in 2015, and, thanks to funding from the Fairfield County Foundation, we were delighted to continue our museum-school partnership with the Hamilton Avenue Magnet School.

To preserve our past for future generations, the Greenwich Historical Society Archives depends on the assistance of people interested in preserving the unique culture of Greenwich. We acquire, preserve and make available to the public publications and original documents about any aspect of the history of the Town of Greenwich from its founding to the present. These can include original letters, diaries, scrapbooks, minutes, reports and publications such as books, magazines, menus, brochures, flyers and campaign literature.

The Museum Collection is comprised of objects that document the material culture of present and former inhabitants of Greenwich and its region. Particular emphasis is given to items connected to the history of Bush-Holley Historic Site or those useful to its interpretation. Objects include, but are not limited to, items associated with Greenwich people, places or events; fine and decorative arts; and maritime, agricultural, industrial and domestic artifacts that reflect the activities of the Bush family during the New Nation and of members of the Cos Cob art colony.

Remembering Eric Knutsen

We note with sadness the passing in October 2014 of longtime Riverside resident, software engineer and local historian Eric Knutsen. Dubbed "Herodotus" by the Innis Arden Golf Club, he researched and wrote the illustrated history published as part of the club's centennial anniversary in 1999. As a member of the Harvard Business Club Community Partners, he volunteered to research and develop a marketing plan to promote the publication of *Building Greenwich: Architecture and Design 1640 to the Present* in 2000, personally interviewing Greenwich

realtors, architects and attorneys to gauge interest in the book and help us determine how many books to publish. With its publication, he transitioned into the Historical Society's lead sales representative, personally responsible for selling and distributing over 1,200 copies of *Building Greenwich*, netting over \$20,000 for the Historical Society. In 2006 the Historical Society presented Eric Knutsen with its Volunteer of the Year Award. Among his other volunteer activities, we note his service to At Home in Greenwich and to the Retired Men's Association.

Reimagine the Campus

Creating a Center for Greenwich History



As we enter our 85th year, the Board has developed a dynamic plan to advance our mission to make an even greater contribution to the community. At the heart of the plan is the reimagining of the Greenwich Historical Society campus to better showcase our nationally recognized historic buildings and landscape and to welcome the entire community.

In the first year of the Campaign, under the leadership of Peter Malkin and with the support of our staff and Koszyn & Company, the Reimagine the Campus Campaign Committee has raised over \$10 million toward fulfillment of its goal. Following 18 months of quiet fundraising, we are excited to announce publicly that the Historical Society is undertaking a major capital campaign to transform the campus of our National Historic Landmark Bush-Holley House by expanding its facilities, improving parking and access, and enriching education and preservation programs.

The Historical Society has engaged award-winning historic preservation architect David Scott Parker to design a visionary plan to reimagine the campus and, enhanced by the exterior restoration of Toby's Tavern, to re-create the once thriving streetscape as it was during the height of the American Impressionist art colony era. The plan provides an elegant new entry with a glass-enclosed lobby and elevator that unifies the site for the first time, offering

accessibility to the upper and lower campus levels from a new lot that more than doubles the current parking capacity.

The restored Toby's Tavern and new building will afford dynamic exhibition and program space in two state-of-the-art galleries, research and archives facilities and storage for our collections. The former exhibition space in the adjoining 1805 Storehouse will become much-needed office space for staff.

With an extraordinary offer from anonymous donors to match every dollar raised in the \$13.5 million Reimagine the Campus Campaign, we have garnered generous additional commitments from our Board and close friends — as well as an impressive list of donors brand-new to the Historical Society — and we look forward to breaking ground on the building in 2017. In recognition of the extraordinary efforts of our Campaign Committee, we are now committed to raising \$5 million to expand our Endowment, for a total Campaign goal of \$18.5 million.

With your support, the Greenwich Historical Society will play an even more essential role in our community by preserving local history at a destination site dedicated to lifetime learning and accessible to all now and in the future. We are proud to undertake this important transformation so that the Historical Society is prepared to serve our beloved community in ever more meaningful and engaging ways for many generations to come.
